Vermont Early Hearing Detection and Intervention (VTEHDI) Program

This position was a collaboration between the University of Vermont Medical Center and the Vermont Department of Health supported by federal funding. This was a dynamic program/position with many different roles, responsibilities, and community collaborations. The program's vision and mission is to ensure every Vermont born baby is supported seamlessly through the EHDI continuum.

Managed and supervised staff. Worked with hospitals to develop and implement inpatient and outpatient newborn hearing screening services, as well as, provide on-going training and support around protocols, reporting results, and equipment selection. Care management, leadership and team coordination. Direct audiology clinical work when needed. Program lead in design, development, testing and implementation of our Childhood Hearing Health Registry which is part of the state's integrated patient health database.

Grant writing, billing compliance and budget management. Strategic planning through grant cycles and beyond, program transition and sustainability. Collaborated with community providers from various professions at the local, state, regional and national level. Served as the state audiology liaison and represented VT nationally for EHDI.

Hearing Outreach Program (HOP)

Audiologist September 2001- January 2005

This position was collaborative effort between the University of Vermont Medical Center and the Vermont Department of Health supported by federal grants and insurance reimbursement. Provided hearing assessments at multiple clinic locations state-wide. Assisted the clinical coordinator with tracking results for appropriate follow-up and provided on-going case management.

Newborn Hearing Screening Program

Coordinator June 2001-June 2004

Coordinated the hearing screening program for three newborn nurseries, including the neonatal intensive care unit, at the University of Vermont Medical Center. Responsibilities included: hiring, training and supervising assistants, tracking annual program statistics, making referrals for outpatient follow-up, reporting results to the state health department, and annual presentations of program performance/changes to the pediatric staff. Inpatient hearing aid checks and baseline hearing test for all ages as requested.
